ACTIVITIES:

A variety of STEM activities working with Year 6-8 students. This will include students going through a design process to create a toy that uses electronic motors and batteries with moving parts.

CURRICULUM LINKS:

With a focus on STEM, students will be provided with opportunities to collaborate across Primary School and High School settings to engage in a joint project incorporating science, technology, engineering and maths.

ADDITIONAL INFORMATION:

All students must wear school uniform and are encouraged to take a water bottle. Students need to bring their own food for recess and lunch.

Please ensure the classroom teacher is informed if your child requires medication whilst on the excursion. The necessary medication must be in the original container, clearly marked with the child's name and with the appropriate health care plan. If the school holds medication and a current health care plan for your child, this will be provided to the supervising teacher for the excursion. Students who self manage their asthma must take their inhalers on the excursion.

We will **require at least 4 parents** to assist with supervision. The DECD volunteering policy has recently changed. Parents or guardians who volunteer in connection with an activity that involves their own child do not require a *relevant history screening* through the Department of Communities and Social Inclusion [DCSI]. However, East Adelaide School Governing Council has strongly recommended the DCSI screening continues for all volunteers. Only the DCSI screening is acceptable and application forms can be obtained from the school front office. Completed forms must be returned to the school for lodging.

Volunteers are required to have completed the Responding to Abuse and Neglect – Education and Care (RAN-EC) training prior to undertaking any volunteer work. The training may be completed online. Register at <https://www.plink.sa.edu.au/pages/signup.jsf> and select the course "Responding to Abuse and Neglect-Education and Care online induction session for volunteers". Once completed, please provide a copy of your certificate of completion to the school. Should you require further information, please contact the school front office.

Please complete and return the slip **below** if you are able to help with supervision. The teacher will contact parents to confirm arrangements prior to the excursion. **Until confirmation of your attendance has been made by the teacher, please do not schedule time off work.**

Please return the attached consent form to the class teacher by Thursday 17 May 2018.
