2024 ICT Acceptable Use Agreement F-6 Computer Network and Internet Use

Dear Parent/Carer,

The measures to ensure the cyber safety of East Adelaide School (EAS) students are based on our core values of Respect, Responsibility, Relationships and Resilience. To assist us to enhance learning through the safe use of Information Communication Technologies (ICTs), we are now asking you to read this document and sign the attached form.

Child protection education and cyber-safety practices are in place, whereby staff and learners are involved in discussions regarding the safe and responsible use of the school ICT facilities. The purpose of these guidelines is to ensure that learning remains engaging, productive and safe. To ensure that EAS students use ICT responsibly, we encourage parents/carers to recognise their responsibilities in supervising and supporting their child's ICT learning experiences both at home and at school. The Use Agreement includes information about students' responsibilities and consequences associated with cyber-safety.

The Child Protection : Keeping Them Safe Curriculum is taught throughout the year and an emphasis is placed on the module related to cyber awareness and safety which is revisited on a regular basis by teachers.

ICT facilities can be accessed in all areas around the school. To promote the safe use of ICTs, we ask you to read, discuss and sign the attached Use Agreement Form. We teach and encourage all students to safely use and to embed ICT tools across the curriculum. Internet use will be for educational purposes only and students will be supervised and monitored by adults.

Material sent and received using the network is filtered by the Department for Education's monitoring software to restrict access to certain sites and data, including e-mail in an effort to prevent students' exposure to inappropriate content. Schools now have direct information from the Department's ICT monitoring system as to inappropriate sites students are accessing whilst on school premises, including before and after school. This will mean opportunities to intervene and implement the teachable moments as issues arise. It will also mean that parents will be informed sooner of any inappropriate use of devices.

The Department for Education's administrators make every reasonable effort to eliminate risks when using the department's online services but it cannot filter internet content accessed by your child from home, from other locations away from school or on mobile devices owned by your child. Where a student is suspected of an electronic crime, this will be reported to the South Australian Police. Where a personal electronic device such as a mobile phone is used to capture images of a crime, such as an assault, the device will be confiscated and handed to the police.

If your child uses a school device for learning during school hours, our expectation is that this equipment will be respectfully used. Students and parents will be required to complete an equipment liability form whereby students/families are held accountable for any damage outside reasonable wear and tear.

Parents/ guardians must give their written permission for their child to use the school system by signing the ICT Acceptable Use Agreement. Students sign the ICT Acceptable Use Agreement and return the form to school which is kept on file in school records. Please contact staff about your child's safety in using the Internet and ICT equipment/devices.

Important Terms

'Cyber-safety' refers to the safe use of the Internet and ICT equipment/devices, including mobile phones.

'Cyber bullying' is bullying which uses e-technology as a means of victimising others. It is the use of an Internet service or mobile technologies - such as e-mail, chat room discussion groups, instant messaging, webpages or SMS (text messaging) - with the intention of harming another person.

'ICT equipment/devices' includes computers, storage devices, cameras, all types of mobile phones, gaming consoles, video and audio players/receivers and any other technologies.

'Inappropriate material' means material that deals with matters such as sex, cruelty or violence in a manner that is likely to be injurious to children or incompatible with a school or preschool environment.

'E crime' occurs when electronic communication devices are used to commit an offence or act as storage in an offence.

Teacher Responsibilities

1. Discussing and regularly revisiting computer responsibilities with students at the start of each year and throughout the year.
2. Implementing the Child Protection: Keeping Them Safe Curriculum.
3. Supervising students' computer use to embed ICT across the curriculum and provide children and families with safe strategies in a connected online world.
4. Following up any issues involving inappropriate use, informing leadership staff and contacting parents/carers.

Student Responsibilities for Computer and Internet Use

Parents/carers and staff play a critical role in developing knowledge, understanding and ethics around students' safety practices. Each student has a responsibility to take care of the computing resources and use them in a careful and constructive way and we invite you to discuss with your child the following strategies to help us stay safe when using ICT at school and after school hours.

Responsibility

1. I will read, sign and follow the Acceptable Use Agreement and use the computing resources for school learning use only.
2. I will not create, send or publish unacceptable or unlawful materials, remarks or photographs including offensive, abusive or discriminatory remarks. I will not use a device to threaten, bully or harass another person.
3. If there is something I'm not sure about, I will ask my teacher and seek support when printing information.
4. I will hand in my mobile phone to my classroom teacher between the hours of 8:45am-3:10pm.
5. I understand the school has the right to collect and examine my device at any time.
6. When using a school device, I understand that I am accountable for any damages beyond any reasonable wear and tear.

Respect

7. I understand that I must comply with teachers' requests to shut down devices or close the screen. I will keep the device I am using in silent mode and put away when asked by the teacher
8. I will use the Internet, e-mail, and any other ICT equipment only for positive purposes and will not tamper with settings, switches, buttons or cables.
9. I will respect and not tamper with other people's work; therefore, I will not be disrespectful to other people.
10. I will log on and off the network correctly and keep my password private and not read any e-mail intended for others.
11. I will not eat or drink when using the computer and I will remain on task and use my time effectively.

Resilience

12. If I find anything that upsets me or that I know is not acceptable at our school, I will:
 - not show others
 - turn off the screen
 - immediately speak with a teacher.

Relationships

13. Only with written permission from home and the school will I bring any ICT equipment/devices to school. This includes things like USB/portable drives, mouse, and headphones.
14. The school cyber-safety strategies apply to any ICTs brought to school. With teacher permission and in compliance with copyright laws, I can download or copy selected files, for learning purposes only, such as text, images, music, videos, or programs.

15. I will ask my teacher's permission before I put any personal information online. Personal identifying information includes any of the following:
- my full name
 - my address
 - my e-mail address
 - my phone numbers
 - photographs of me and/or people close to me.
16. I will be careful and will look after all our school ICT equipment by:
- not intentionally disrupting the smooth running of any school ICT systems
 - not attempting to hack or gain access into any other system
 - following our school cyber-safety strategies
 - treating the school equipment respectfully and not cause intentional damage
 - reporting any breakages/damage to a staff member.
17. If I'm not cyber-safe, the school may need to inform my parents/caregivers and there may be consequences associated with my behaviour.
18. I understand that appropriate apps I should be using on devices are:
- Microsoft 365 Suite
 - Minecraft Education (not Minecraft Java or Bedrock)
