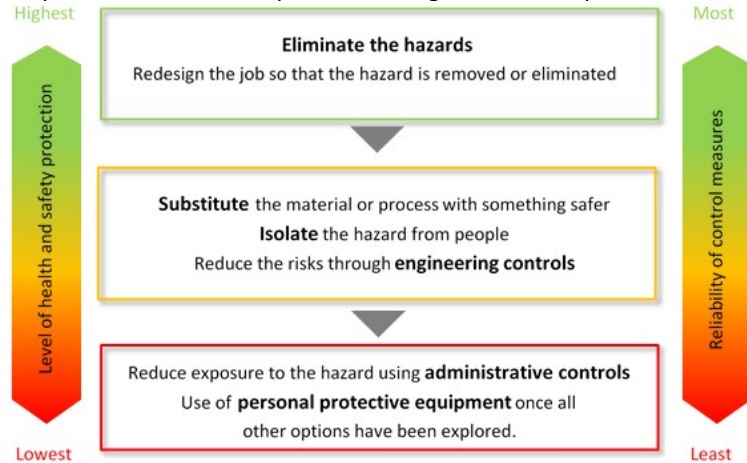

Stacked large blocks on or near stage may fall or shift during use or play	<ul style="list-style-type: none"> <li>Children not permitted to climb stacked blocks</li> <li>Blocks checked daily for stability</li> <li>High-risk stack removed or repositioned as needed</li> <li>Stage area off-limits unless supervised directly by staff</li> </ul>	<b>Moderate</b>
Absconding or unauthorised egress via main Performing Arts exit	<ul style="list-style-type: none"> <li>Main exit remains monitored</li> <li>Daily zoning includes Performing Arts space</li> <li>Headcounts conducted when moving to or from this area</li> <li>Active supervision</li> </ul>	<b>Low</b>
Movement to toilets or other zones	<ul style="list-style-type: none"> <li>Children must seek staff permission before leaving for the toilet</li> <li>Toilets and approved areas only accessible via clear pathways and supervision</li> <li>Active supervision positioned to monitor all movement points</li> <li>Walkie talkies used to check-in across spaces as required</li> <li>Refer to separate <b>Risk Assessment: Sexualised Behaviour</b> for detailed controls</li> <li>Regular checks and staff stationed near entry</li> <li>No more than 3 children permitted at a time without supervision awareness</li> </ul>	<b>Low</b>
<b>Inappropriate or unsafe use of musical instruments</b> (e.g. hitting others, misuse of equipment)	<ul style="list-style-type: none"> <li>Clear rules communicated before instrument access</li> <li>Instruments stored out of reach when not in structured use</li> <li>Staff supervise all musical activities</li> <li>Equipment checked regularly for breakages or loose parts</li> </ul>	<b>Low</b>

**Step 2:** Identify controls for your remaining hazards. Use the hierarchy of control chart to help select controls that provide the highest level of protection to employees.



**Step 3:** Assess the level of risk for the remaining hazards with all controls in place.

<b>Extreme</b>	<p><b>Do not undertake the activity</b></p> <ul style="list-style-type: none"> <li>Contact the Work Health and Safety team on <a href="mailto:Education.WHS@sa.gov.au">Education.WHS@sa.gov.au</a> or on 8226 1440 for guidance on risk reduction</li> <li>Consult with workgroup Health and Safety Representative where available</li> </ul>
<b>High</b>	<p><b>Reduce the risk as far as reasonably practicable</b></p> <ul style="list-style-type: none"> <li>Escalate to site leader and/or local safety/ management committee for review</li> <li>Consult with workgroup Health and Safety Representative and affected parties</li> <li>Review department <a href="#">WHS safety management</a> intranet for control requirements</li> </ul>
<b>Medium</b>	<p><b>Activity may be undertaken</b></p> <ul style="list-style-type: none"> <li>Consider ways to further reduce the risk and review the department <a href="#">WHS safety management</a> intranet</li> <li>Consult with workgroup Health and Safety Representative or affected parties</li> </ul>
<b>Low</b>	<p><b>Activity may be undertaken safely</b></p> <ul style="list-style-type: none"> <li>Monitor the activity and controls to ensure the risk remains low</li> </ul>
